Term and Conditions:

- 1. Rates quoted in the item rate should be valid for the complete contract period as no changes in the price bid would be considered at to the end of contract period.
- 2. The rates quoted in the price bid will be inclusive of all taxes, fees, levies etc.
- 3. The invoice should contain PAN No., GST No. and address of the bidder when the payment has to be made.
- 4. Bank will have all the rights that without any intimation the contract can be terminated without notice of any deviation noticed.

- 6. The bidder should be a company registered in India under the Indian Companies Act 1956/2013 or a partnership or a society constituted under the Societies Registration Act 1860 or sole proprietor firm with their registered office in India for the last five years as on 31st March, 2024.
- 7. The bidder should have valid TIN/ Services Tax/GSTN registration.
- 8. The bidder should have a technical support office in operation in Andhra Pradesh and support centers manned with qualified staff.
- 9. The bidder should not be barred or black- listed by any central/ state govt. departments/ organizations/PSUs for any reason for the last 5 years.
